6 specific objectives



1. Connectivity increase access to resources. Reduce the environmental temperature. Improve habitat for pest predators.



2. Economic. Generate marketable products. Reduce energy consumption. Increase the value of the property. Provide alternative sources of energy. Provide ecosystem services. Silvo-pastoral system.



3. Water Catch contaminants in surface runoff. Catch contaminants in the sub-surface flow. Reduce the erosion of the banks. Protect against flood waters. Create a safe environment




4. Soil Reduce soil loss due to water and wind erosion. Improve infiltration. Stabilize the soil. Improve the quality of the soil. Remove contaminants from the soil.



5. Protection. Reduce wind power over the city. Modify the microclimate. Reduce the levels of flood waters and erosion. Reduce the risks. Protect against wind or snow Increase the control of biological pests.



6. Quality of life. Improve visual interest Hide undesirable views. Dim the undesirable noise. Filter air pollutants and undesirable odors. Separate human activities. Promote recreation based on nature. Use buffer zones as recreational trails.
