#### FROM BUCHAREST AIRPORT

Braşov is located in central Romania and can be reached by train (2h 40min from Bucharest North train station <u>Train itineraries - CFR trains timetable</u>). Henri Coandă Otopeni international airport is the largest and the closest international airport, which is located 12 km north of Bucharest. There is a direct train from the international airport to Bucharest North train station.

#### AIRPORT SHUTTLE FOR THE BUCHAREST AIRPORT

The transfer from/to Henri Coandă Otopeni international airport to/from Brașov can also be done by airport shuttle. They can pick you up at the airport/hotel and drop you in front of your hotel in Brașov/Henri Coandă Otopeni international airport.
